8. Nature of duties:

- A. While working a Veterinary Surgeon in Haryana I was responsible for management of breeding, feeding, management and health of cross bred and indigenous cattle and equine farms.
- B. While working at Central Sheep and Wool Research Institute, Avikanagar I was responsible for flock health management.
- C. Responsible for management of buffaloe herd at Central Institute for Research on Buffaloes, Hisar.
- D. While working as Director, Animal Husbandry, Govt. of NCT of Delhi from 6th September, 2002 to 4th September, 2008. the following major achievements were made:
- l. Physical and Financial targets of all the Schemes being implemented in the department were achieved to the tune of almost 100 per cent.
- II. Four dog sterilization centres were set up in Veterinary Hospitals to help Municipal Corporation of Delhi in Animal Birth Control Programme. Operation theatres were established at these centres.
- III. Some key Veterinary Hospitals were made functional on Sunday with OPD services on all seven days of the week. In addition, emergency services were started in some veterinary hospitals with the timings 7.00 AM to 2.00 PM and 4.30 PM to 11.30 PM.
- IV. Situation arising as a result of out-breaks of Bird Flu in India was efficiently handled. A close watch was kept on the birds coming to Egg and Poultry Market, Gazipur by the Veterinarians of the Department and staff of Delhi Society for Prevention of Cruelty to Animals by appointment of Nodal Officers and Constitution of Rapid Response Teams.
- V. Livestock Census was successfully conducted in the years 2003 & 2007 and reports of both the censuses were compiled and submitted to Govt. of India well in time.
- VI. Case of transfer of Delhi Milk Scheme from Govt. of India to Govt. of NCT of Delhi, pending since long was decided and settled after the approval of Cabinet of Ministers.
- Vil. Case of grant of time bound ACP to the veterinarians of the department as per the recommendations of the committee constituted by Chief Minister, Delhi was settled after the approval of Cabinet of Ministers.
- Vill. All cases of Assured Career Progression (ACP) to Group —D, and Group C employees of Animal Husbandry and Fisheries Departments, pending since long were decided and no case of ACP was left pending.
- IX. Employees with different designations like Stock Assistant, Stock Man, Veterinary Compounder, Milk Recorder and Animal Husbandry Assistant but doing same kind of duties were merged with a single designation as Veterinary and Livestock Inspector and recruitment rules were framed accordingly.
