- The Applicant already in service should send his/her application through proper channel. 1. However, advance copy of application form can be considered subject to submission of NOC from his/her employer at the time of screening test/interview.
- 2. Merely fulfilling the minimum qualification or the eligibility criteria does not entitle a candidate necessarily considered or called for the Screening Test/Interview.
- The age of the applicant should not be less than eighteen years on the last date of application. 3.
- 4. Self Attested copies of all relevant documents must be enclosed along with application form including qualification/experience. Incomplete application in any respect and application received after the last date will not be entertained.
- Certificate in support of experience should be in proper format i.e. it should be on the 5. Organization's/Institute's letter head, bear the date of issue, indicate specific period or nature of work, name and designation, Pay band with GP etc issued by the employer, failing which the same will not be considered.
- Reference of advertisement No. and post applied for should be mentioned on the envelope 6. compulsorily.
- To reduce the number of candidates to a reasonable size, University may adopt 7. appropriate screening criteria based on experience/ academic qualification/ general knowledge and desirable skills.
- Candidate must fulfill required minimum qualifications up to the last date for submission 8. of application form.
- Retired persons under the age of 65 years may also apply. 9.
- 10. No T.A./D.A. will be paid for appearing in screening test/interview.
