Tantia Dental College, Hospital and Research Centre, Shri Ganganagar, Tantia University Campus, Hanumangarh Road, Sri Ganganagar**. On careful consideration of the proposal, the Government of Rajasthan has decided to issue an Essentially Certificate to the applicant for the establishment of a Dental College with 100 seats.

It is certified that: -

- (a) The applicant owns and manages a 500 bedded hospital which was established in 2016.
