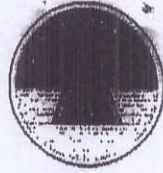

Indian Nursing Council has granted the approval to Tantia University, Rajasthan taken as an Authority under Section 10, Indian Nursing Council Act 1947 for the purpose of said Act subject to the following condition w.e.f 7th October, 2015:

- m. No distance education under Nursing can be offered by Private University.
- n. No Nursing program including Ph.D.(N) can be offered without the permission of Indian Nursing Council.
- o. Nursing Faculty will be a member of examination/Academic Board/Council.
- p. ANM & GNM cannot be offered by the University. Examination for these courses will be conducted by State Nursing Council/exam board.
- q. Only those programmes shall be offered which are recognized by INC. Just changing the nomenclature of the courses i.e. Home care provider etc. shall not be offered by the University.
- r. Faculty of Nursing should be independent and not under the Faculty of Science/Faculty of Medicine.
