Sub: Application for letter of permission for the functioning of Sri Ganganagar Homoeopathic Medical College, Near RIICO Bus stand, Sriganganagar, Hanumangarh Road, Rajasthan-335002 for continuing BHMS course with intake capacity of 100 seats and for PG course with 30 seats in 06 subjects namely Organon of medicine with 05 seats, Materia Medica with 05 seats, Repertory with 05 seats, Practice of Medicine with 05 seats, Psychiatry with 05 seats and Pediatrics with 05 seats for academic year 2025-26 - reg.

Sir,

Sri Ganganagar Homoeopathic Medical College has applied for permission for the sanction of BHMS course with 100 seats and PG course with 30 seats for the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 04.06.2025 & 05.06.2025 and hearing conducted on 24.06.2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

1. Teaching faculty.

- Professor in the Department of Pathology.
- Professor in the Department of Community Medicine.

As evident from the above statement, a total number of two teachers are deficient against the requirement of 40+1 for 100 seats UG college (As specified in MES,2024). Pursuant to F.No.: 3- 2/MARBH/NCH/2025-26/162-169 dated 16/04/2025 issued by MARBH, a college can avail 10% relaxation against the required number of teachers for Academic Year 2025-26 only. After allowing relaxation of 10%, college has no deficiency of teachers. However, such a relaxed number of teachers may be appointed at the earliest for smooth conduct of course.

2. Miscellaneous

- The salary of teaching staff and non-teaching staff is not as per MES 2024.
- 3. Considering the above observations during inspection and hearing MARBH has decided to issue Conditional Permission to Sri Ganganagar Homoeopathic Medical College, Near RIICO Bus stand, Sriganganagar, Hanumangarh Road, Rajasthan-335002 for continuing BHMS course with intake capacity of 100 seats and for PG course with 30 seats in 06 subjects namely Organon of medicine with 05 seats, Materia Medica with 05 seats, Repertory with 05 seats, Practice of Medicine with 05 seats, Psychiatry with 05 seats and Pediatrics with 05 seats for the academic year 2025-26 on the basis of following condition: -
 - The salary of the staff should be as per the criteria mentioned in MES 2024.

- **4.** All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the permitted intake capacity of 100 UG and 30 PG seats shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be shall be conducted by the concerned counseling authority of the state/UT.
- 5. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/ AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.
- 6. Conditions under point 3 should be fulfilled within a period of one month and the compliance report shall be submitted for verification to the office, failing which permission for the academic year 2025-26 may be withdrawn.
